

The firm M/s Multilynx, Lahore is hereby blacklisted for the purchase of servers and cross debarred from participating in relevant category of Procurement in Directorate General MIS tenders with immediate effect from issuance of this letter for a period of three years under Rule 19 1 (b) of the PPRA Rules-2004 (as amended from time to time) on account of failure to perform its obligations and submitted undertakings as given in Purchase Order/Acceptance Letter and bid acceptance forms in serious violations of relevant rules and provisions of the bidding documents. Aforesaid non compliances/failures have caused collateral loss and serious delay to the completion of flagship project/reforms under process in Directorate General MIS, CGA.

**VIOLATION OF PUBLIC PROCUREMENT REGULATORY
AUTHORITY ORDINANCE, RULES & REGULATIONS FOR NON
DELIVERY OF SERVERS AND ALLIED HP HARWDARE FOR FABS**

A Purchase Order No. 58/IFB.30/MIS/FABS/Proc/Basis-N.W/2021/Vol-II/591 dated 23.04.2022 was issued to M/s Multilynx upon fulfillment of PPRA Rules & Regulations for open competitive bidding method to supply a turnkey hardware solution, comprising 17 HP Servers and Allied Equipment within 08 to 12 weeks (Minimum 56 days to Maximum 84 days ending 15.07.2022) from issuance date of purchase order.

2. Despite written intimation by this office vide letters dated 19.07.2022, 22.08.2022 email dated 14.09.2022, and lapse of considerable time, your firm has failed to deliver the subject consignment in violation and breach of legal covenants under bidding terms and conditions of tender No. IFB-30, and non adherence of Public Procurement Rules, 2004. Finally, this office is left with no other choice, except to initiate the legal proceedings in the light of PPRA Rules 17 to 19.

3. Your reply should reach this office within 07 days from issuance of this letter, as to why legal proceedings may not be initiated and liquidity damages not be imposed on your firm alongwith forfeiting performance bank guarantees of Rs. 53,720,976/- and Rs.13,430,244/.
